Funding Application Requirements:

Consideration is given to community or charitable programs, projects and initiatives that meet the following principles:

- Delivers direct, tangible, on-the-ground support
- Provides long-term and enduring support beyond the life of the mine/project
- Creates value and additional opportunities for the community and its members
- Builds toward a sustainable and healthy community
- Involves Trekor employees or their families in program delivery
- Provides an opportunity to offer in-kind assistance (eg. use of Trekor meeting facilities, access to communication networks, and business-related expertise and skills)
- Aligns with Trekor’s Corporate values: Resourceful, Honest, Purposeful and Committed

We will not consider applications for the following:

- Retroactive requests
- Individual person or team, rather than an organization (except in exceptional circumstances)
- Funding of operating costs (salaries, utilities and overhead costs)
- Initiatives or Programs that create dependency on our support
- Initiatives where there is no clear identification of how the money will be spent
